# <u>P159 'Extending the Scope of E-mail Communications under the Code':</u> <u>Detailed Level Impact Assessment</u>

P159 seeks to extend the current provisions within the Balancing and Settlement Code regarding use of email, in order to authorise email as an acceptable medium for individual notices and communications given in accordance with paragraph H 9.2 of the Code. Currently, H 9.2 only expressly provides for individual notices and communications between Parties to be sent by post or fax.

A number of Balancing and Settlement Code Procedures already provide for e-mail communications between Parties (including BSCCo), and P159 would therefore largely confirm existing practice whilst removing any perceived inconsistency between the provisions of the Code and of these BSCPs.

However, authorisation of e-mail for all notices and communications would also cover communications which are not currently sent by such means. In line with the suggestion of the Proposer of P159, the Governance Standing Modification Group has therefore developed a set of express exceptions where it believes that it would not be appropriate for certain communications to be sent solely by e-mail.

P159 covers communications between the following parties under the Code and Code Subsidiary Documents:

- BSCCo (including BSC Clearer);
- The Panel (including Panel Subcommittees, Modification Groups and respective secretaries);
   and
- BSC Parties (including the Transmission Company).

P159 therefore has no impact upon BSC Agents, Party Agents or the Authority. No impact on any other Core Industry Document has been identified by the GSMG.
