<b>Title of Modification Proposal</b> <i>(mandatory by originator):</i> Removal Of Obligation To Publish Price Data In Ft

<b>Description of Proposed Modification</b> <i>(mandatory by originator):</i> A proposal to remove the obligation on BSCCo to publish System Sell Price and System Buy Price information in the press. It is proposed that the price data should continue to be published on the BSC Website.	
<b>Description of Issue or Defect that Modification Proposal Seeks to Address</b> <i>(mandatory by originator):</i> This proposal seeks to realise cost savings in the publication of data. The very high cost of daily publication of price data in the press is no longer justified, given the accessibility of the data via the BSC website.
