Transmission Questions

Question 1:

Please describe the impact(s) of the Proposed Modification on your ability as a Transmission Company to discharge your obligations efficiently under the Transmission Licence and to operate an efficient, economical and co-ordinated transmission system.

National Grid does not expect P241 to have any impact on our ability to discharge our obligations efficiently under the Transmission Licence, as it seeks to preserve the status quo.

Question 2:

Please outline your views and rationale on whether the Proposed Modification would help to achieve the applicable BSC Objectives.

Please give your response:

National Grid believes that the section K drafting introduced by P162 inadvertently created a more onerous requirement to meter plant within CCGT modules than is actually necessary.

National Grid agrees with the Group's view that removing the requirement to install and maintain meters on licensable generating units within CCGTs (i.e. where meters are not required for settlement purposes) would remove an obstacle to market participation and hence better facilitate Applicable Objective (c).

National Grid also agrees with the Group's view that removing the requirement to install and maintain meters would also remove the need to read the meters and process/administer the administered data, thereby better facilitating Applicable Objective (d).
