We believe that Alternative B would better facilitate Applicable BSC Objective c) by encouraging all parties to raise proposals in that they can ensure their solution is presented to the Authority. It would also better facilitate BSC objective d) by allowing a proposer to develop and refine their proposal allowing the correction to oversights. This would remove the need for parties to raise subsequent modifications to resolve such oversights. It would also introduce a withdrawal process that would remove the risk that a modification is progressed that has no business case or has lost the support of the proposer and industry.

Alternative A would better facilitate Applicable BSC Objective c) by encouraging all parties to raise proposals in that they can ensure their solution is presented to the Authority. However, on balance would not better facilitate BSC objective d) due to the potential inefficiency created by trying to represent the conflicting views at the panel and noting that is presently done by Elexon thereby creating duplication.
