### **Title of Modification Proposal:**

Profile Administrator: creating flexibility in discharging the service

**Description of Proposed Modification** (mandatory by originator)

Modify the BSC such that ELEXON (as BSCCo) is able to itself (without restriction) discharge the duties of the Profile Administrator (PrA) in whole or in part, where ELEXON identifies this to be the most efficient method of such duties being discharged. This may include for reasons of economic efficiency.

**Description of Issue or Defect that Modification Proposal Seeks to Address** (mandatory by originator)

Section E of the Code defines the PrA as a BSC Agent. The principal functions of the PrA are set out in 4.2 of Section S. There is a provision in Section C for ELEXON (as BSCCo) to provide the PrA service itself under certain circumstances - i.e. where attempts to appoint a PrA have been unsuccessful and the Panel's prior consent has been obtained. ELEXON cannot currently undertake any part of the PrA service itself unless these circumstances are met.

In addition, the Code does not currently permit ELEXON to provide the PrA service itself for any period exceeding one year without further Panel approval.

These Code constraints can be said to restrict ELEXON's ability to ensure the most efficient discharge of the PrA service.
