#### Re: Modification Proposal P179 – Housekeeping Modification

Thank you for the opportunity of responding to this draft modification report considering Modification Proposal P179. British Gas Trading (BGT) agrees with the Panel's provisional recommendation that the Modification Proposal will better facilitate Applicable BSC Objective (d).

BGT has some issues with the proposed legal drafting that has been provided. BGT has identified a typographical error in Section K3.4.2A of the proposed legal text. The text states "increases in the of the negative value of ….", the words that are struck out need to be removed. BGT also questions the change proposed under Section W4.2.1. BGT believe it is appropriate that the wording should remain as 'shall' rather than being changed to 'may'. BGT understands that the actions detailed in Section W 4.2.1 require Panel approval, so the Trading Disputes Committee (TDC) would be obligated rather than having the choice to recommend rectification via one of these routes. BGT also questions whether this change falls within the scope of a housekeeping change as it appears to be changing the options available to the TDC rather than amending an inconsistency or manifest error.

BGT agree with the proposed implementation date.

No	The nature of most of the proposed changes is to change the Code to rectify errors. However, the changes to section W have the effect of changing the meaning of the Code.

Please give rationale.	No	Although most of the changes will rectify errors to the Code, change 22 does not rectify the perceived error in W4.2.1 of the code highlighted in the original Modification Proposal. Replacing ' <b>shall</b> recommend' with ' <b>may</b> recommend' still does not put it right. Change 22 should be withdrawn from the modification and treated as a modification in it's own right.
3.	Do you agree with the Panel's provisional recommendation concerning the Implementation Date for P179? Please give rationale.	Yes	There is no obvious need to delay implementation

4.	Are there any further comments on P179 that you wish to make?	Yes	We disagree with the removal of change 21 from the modification. The TDC or Panel needs to determine whether there was a settlement error and the materiality is greater than the threshold (4.1.1A) they have to do one of 3 things ie a, b or c to correct the settlement error, therefore 4.1.1 should read <b>'shall</b> determine' not <b>'may</b> determine'.
