Requirements and Solution

Brief Summary of Change

Modification Proposal P171 'Retrospective removal of Emergency Instructions taken for System reasons from Imbalance Price' was raised on 25 August 2004. P171 seeks to remove Emergency Instructions issued for System balancing reasons from Imbalance Prices. It is the intention that P171 would apply on a retrospective basis (i.e. would apply to historic Emergency Instructions).

LogicaCMG's Proposed Solution

Following discussions with the ELEXON lead analyst we have identified two possible solutions to Option 1 - Automated Solution. These differ by whether or not the affected volumes are identified in the system and reports. For both solutions we have assumed that the low data input volumes allow a manual interface for data entry and thus there is no need for a new data flow and its associated costs but there will be a per event operate charge.

Option 1A – Automated Solution – Un-priced Volumes not uniquely identified

We have assumed that

- partial tagging of an acceptance is not required
- there is no requirement to record / report the split of un-priced volumes between Emergency Instructions and CADLed volumes
- that amendments will not be applied to BMRA and BMRA will not repeat its settlement process.

The activities required are:

- Update documentation with new reporting requirements and manual information flows
- Modify the "Maintain Bid/Offer Acceptance" screen to allow Emergency Instruction Flag to be viewed / amended.
- Change the Accepted Volume calculations to record un-priced volume for Emergency Instructions and the Emergency Instruction accepted volumes.
- Change imbalance price calculation to exclude tagged volumes.
- Change the settlement reports to identify acceptances which represent Emergency Instructions.

Option 1B – Automated Solution – Record/Report split of un-priced volumes between Emergency Instructions and CADLed volumes.

We have assumed that

- partial tagging of an acceptance is not required
- there is a requirement to record / report the split of un-priced volumes between Emergency Instructions and CADLed volumes
- that amendments will not be applied to BMRA and BMRA will not repeat its settlement process.

The activities required are:

- Update documentation with new reporting requirements and manual information flows
- Update operational instructions
- Modify the "Maintain Bid/Offer Acceptance" screen to allow Emergency Instruction Flag to be viewed / amended.
- Change to Accepted Volume calculations to record un-priced volume for Emergency

Instructions as a separate volume and to record the Emergency Instruction accepted volumes.

- Change imbalance price calculation to exclude tagged volumes.
- Change to settlement reports to identify acceptances which represent Emergency Instructions and separate un-priced CADL / Emergency Instruction volumes

Option 2: Manual Solution

We have assumed that there are no changes to reporting and amendments will not be applied to BMRA and BMRA will not repeat its settlement process.

Activity required to update documentation to reflect the manual processes to:

- Receive Adjusted prices from BSCCo.
- Calculate revised BSAD
- · Perform additional Settlement Run to verify BSAD adjustment
- Confirm results of additional run and agree with BSCCo.
- Repeat for all runs after II.

Option 3: Potential Manual Alternative

We have assumed for this option that there are no changes to reporting, that amendments will not be applied to BMRA and BMRA will not repeat its settlement process and that ad-hoc charges and cash flows are calculated and progressed by BSCCo with no additional involvement from NETA CSA.

Activity is required to update documentation to reflect the manual processes required to:

- Receive adjusted Bid-offer pair prices from BSCCo
- Apply changes to SAA before the SF run.

Option 4: Manual Solution

Tasks are the same as for Option 2 (even though the BSCCo tasks differ) See Option 2 above for details.

Deviation from ELEXON's Solution / Requirements

Operational Solution and Impact

Options 1A, 1B, and 3 have a per event requirement to enter amended data.

Options 2 and 4 have a slightly larger requirement as some reports will need to be re-run as well as the data entry task.

Validated Assumptions

- 1) There is no requirement for partial tagging of an acceptance. (So each instruction either is or is not an Emergency Instruction)
- 2) Value amendments will not be applied to BMRA and BMRA will not need to repeat its settlement process.
- 3) Ad-hoc charges and cash flows are calculated and progressed by BSCCo with no additional involvement from NETA CSA.
- 4) All modified data would be for periods within the current scheduled settlements cycle.
- 5) Option 2 and Option 4 are the same SAA process.
- 6) Amendment of business data will require agreed data to be present 1 working day prior to an II run and 5 working days prior to SF and later runs.
- 7) These changes are a low volume activity i.e. less than 10 occurrences per year.
- 8) There is no impact on the settlement calendar.
