**Title of Modification Proposal** (mandatory by proposer):

**Appeal Mechanism for Panel and Panel Committee Decisions** 

**Submission Date** (mandatory by proposer): 1 December 2003

**Description of Proposed Modification** (mandatory by proposer):

Modify the Code to provide for an appeal process on Panel and Panel Committee decisions, where a party reasonably believes that such a decision is inconsistent with Panel objectives or materially prejudices the interests of a particular Party or class of Parties.

In the case of decisions taken by Panel Committees under delegated authority, any appeal should be to the Panel.

In the case of Panel decisions, any appeal should be to the Authority.

**Description of Issue or Defect that Modification Proposal Seeks to Address** (mandatory by proposer):

Because they relate to the detailed functionality of the systems and business processes of Parties and their Party Agents, changes to Code Subsidiary Documents and other documents referred to in the latter can often have a much more significant impact on Parties (and ultimately on customers, in terms of costs) than changes to the Code itself.

The lack of an appropriate appeal mechanism and delayed communication of Panel/Committee decisions and/or the reasons for these may unfairly prejudice the interests of (i.e. discriminate against) certain Parties or classes of Parties and means that decisions may sometimes made which cannot be undone without having a retrospective impact. This is clearly unsatisfactory.

- d) Promoting efficiency in the implementation and administration of the balancing and settlement arrangements by ensuring that all proposed changes to BSC related documents are subjected to proper scrutiny, so that the need for costly revisions and unjustified BSCCO operational costs are avoided.
