Title: Housekeeping Changes to Settlement Documentation	
Description of Problem/Issue ELEXON has identified a number of Code Subsidiary Documents and other Configurable Items that require minor housekeeping changes in order to correct manifest errors, resolve inconsistencies and remove redundant requirements.	
Proposed Solution(s) <i>(mandatory by originator)</i> The set of proposed changes are contained in the attachment to this CP. In addition to these specific changes, this CP proposes the replacement of the Poolit copyright statement prevalent in many of the Supplier Volume Allocation (SVA) documents. Going forward under the GB BSC, all settlement documentation should be brought under the copyright control of ELEXON Ltd as the GB BSCCo.	
Justification for Change <i>(mandatory by originator)</i> The changes identified are not material however their implementation will improve clarity and ensure the documents are fully reflective of current operational processes. It is intended that these changes be carried out alongside the re-badging activities required for BETTA, which are expected to impact almost all settlement documentation.
