**Title** (mandatory by originator)

Amendment to Registration Reports to Include BM Unit Information

**Description of Problem/Issue** (mandatory by originator)

This CP refers to amendments to the Registration Report (CRA – I014) and to the Operations Registration Report (CRA – I020).

The intent of the CRA – I014 report has been to confirm those registration amendments made directly by BSC Parties (i.e. BSC Party request direct to the CRA) to their BM Units. Therefore there are data items, registered or amended by BSCCo, or derived by the Central Registration Agent (CRA) that are not reported in the report. Thus BSC Parties are not aware of changes to such data for their BM Units.

Registration of, or amendment to, the following data items is not reported on the CRA – I014:

- BM Unit Credit Assessment Export Capability (BMCAEC) derived by CRA;
- BM Unit Credit Assessment Import Capability (BMCAIC) derived by CRA;
- Transmission Loss Factor (TLF) registered and amended by BSCCo; and
- Credit Assessment Load Factor (CALF) registered and amended by BSCCo.

The CRA – I020 is provided to BSCCo and the Transmission Company to report on BM Unit registrations (amongst other things). This report also excludes data items relevant to BM Unit registrations, namely:

- BM Unit Credit Assessment Export Capability (BMCAEC);
- BM Unit Credit Assessment Import Capability (BMCAIC); and
- Credit Assessment Load Factor (CALF).

Thus BSCCo (and to a lesser extent the Transmission Company) cannot determine what data is registered against each BM Unit.

#### **Proposed Solution(s)** (mandatory by originator)

Add the listed data items into the relevant part of the report, as follows:

Registration of, or amendment to, any of the following data items will be reported on the CRA – I014, Sub flow 5 (BM Unit registration) on initial registration and then as and when changed:

- BM Unit Credit Assessment Export Capability (BMCAEC);
- BM Unit Credit Assessment Import Capability (BMCAIC);
- Transmission Loss Factor (TLF); and
- Credit Assessment Load Factor (CALF).

initial registration and then as and when changed:

- BM Unit Credit Assessment Export Capability (BMCAEC);
- BM Unit Credit Assessment Import Capability (BMCAIC); and
- Credit Assessment Load Factor (CALF).

It should be noted that currently the CRA – I020 'Operations Registration Report' is provided to BSCCo and to the Transmission Company in spreadsheet form, as introduced (at NETA GO-live) by Workaround 16, as a consequence of the data format / structure of the CRA – I020 not meeting the specific requirements of BSCCo and the Transmission Company.

There is currently an ELEXON initiative in place to review the CRA – IO20 and to amend it to provide the data in the required format / structure, however, it should be noted that this initiative is separate from this Change Proposal, and therefore the amendments detailed in this CP will initially be made to the spreadsheet CRA – IO20, pending completion of the BSCCo initiative.

#### **Justification for Change** (mandatory by originator)

BSC Parties should be able to determine the data registered for any of their BM Units by the CRA at any time, and on any amendment to the data. Therefore addition of the listed data items to the report provides each BSC Party with the requisite information on their BM Unit registrations.

The same can be said for BSCCo (and to a lesser extent the Transmission Company), as BSCCo should be able to determine what has been registered by BSCCo for a BM Unit (specifically CALF (as TLFs are already included in the CRA – I020), and what has been derived by CRA for a BM Unit (BMCAEC and BMCAIC) from data held in the CRA.

The implementation of Approved Modification P100 introduces new data items (Base Trading Unit Flag, Exempt Export Flag and Production / Consumption Status) into both the CRA – I014 and the CRA – I020, and therefore it is seen as an opportune time to amend both reports to include and report the full complement of BM Unit data / information.

Furthermore, the amendment to the reports will be made without cost to ELEXON (and therefore to BSC Parties) as a consequence of the amendments listed above being absorbed into the effort required for the amendments being made for P100.
