<p>Title <i>(mandatory by originator)</i> Modification P10 – Removing De Minimis Acceptances from the Calculation of SBP/SSP</p>	
<p>Description of Change <i>(mandatory by originator)</i></p> <p>Amend the Imbalance Price (SBP/SSP) Calculations to exclude all Bid/Offer Acceptances with a volume less than a De-Minimis Acceptance Threshold (DMAT). The threshold to be set by the Panel, initially at 1 MWh.</p>	
<p>Proposed Solution(s) <i>(mandatory by originator)</i></p> <ol style="list-style-type: none"> 1. Implement a new operator-maintained parameter (DMAT) in SAA and BMRA, configurable for a Settlement Day. A parameter value of zero will indicate that the threshold is not to be applied for a Settlement Day. 2. For SSP and SBP calculations in BMRA and SAA, exclude all Bid/Offer Acceptances with an absolute Acceptance Volume less than or equal to the value of DMAT. 3. Make no changes to Balancing Payments for BM Units where Acceptances were below DMAT. 4. Display the value of DMAT on the ELEXON web site. 	
<p>Justification for Change <i>(mandatory by originator)</i></p> <p>These changes will ensure that the Trading Arrangements are brought into line with the Modification P10, which was approved by the Panel and made effective from Settlement Day May 11th.</p>
