I only really want to make one comment this year. I want to encourage ENTSO-E to be ever more open with its Network Code development and as we move forward, particularly with the implementation of the Network Codes. And to engage more with stakeholders and on a daily basis where necessary. I very much welcome the consultations and stakeholder workshops as part of this and ENTSO-E has greatly improved on this is recent years. However, these are just snapshots of proposals where decisions have already been largely made and the detail given in these is insufficient to design the interfaces with the TSOs' projects. When we come to the detailed implementation of the Network Codes, e.g. of balancing pilot projects under the Electricity Balancing Guideline, there will need to be detailed and ongoing discussions by TSOs with non-TSO stakeholders, such as with my employer, ELEXON, which is the imbalance settlement responsible party for GB. We need to adjust and seek local regulatory approval to amend our market arrangements to interface with the new CoBA and then pan-European arrangements of which our TSO is part. And this level of cooperation means close daily coordination so that all potential changes to the detailed arrangements are flagged and discussed with us as early as possible. We can help you make the CoBAs and Network Codes in which we are involved work, but we need ENTSO-E and the relevant TSOs in a CoBA to engage with us at a detailed level. This is a 'win-win'.
