

<b>Change Proposal – BSCP40/02</b>	<b>CP No:</b> CP1461  <i>Version No: 1.0</i> <i>(mandatory by BSCCo)</i>
<b>Title</b>  Amending BSCP128 to reflect a new simple SVA file format for LDSO LLF submissions.	
<b>Description of Problem/Issue</b> (mandatory by originator)  Licensed Distribution System Operators (LDSOs) are required to submit Line Loss Factors (LLFs) in a D0265 ‘Line Loss Factor Data File’ file format. Where an Embedded LDSO mirrors the Host LDSO LLFs, they repeat data that is already held by BSCCo to create the D0265 file. The format is a 365*48 dataset per LLF Class, which can become very large. Embedded LDSOs that create this file require systems or manual copying and pasting to generate the file, which implies additional burden and/or potential for errors.  A system has been developed centrally to create D0265 files on behalf of embedded LDSOs, and this has operated successfully. However, this system has not yet been formalised in the BSCP, and therefore the BSCP does not reflect operational processes.	
<b>Proposed Solution</b> (mandatory by originator)  The system developed by ELEXON provides a simple file format that enables the Embedded LDSO to copy Host LDSO LLFs. It reduces complexity in the process and prevents non-compliance issues in file formats. The simple file format has operated successfully. As such, it should be formalised in <a href="#">BSCP128 'Production, Submission, Audit and Approval of Line Loss Factors'</a> so that the documentation reflects operational processes.	
<b>Justification for Change</b> (mandatory by originator)  The simple file format is a more robust and efficient process that has been successfully used in operational practice. Updating BSCP128 will formalise the process.	
<b>To which section of the Code does the CP relate, and does the CP facilitate the current provisions of the Code?</b> (mandatory by originator)  Section K ‘Classification and Registration of Metering System and BM Unit’	
<b>Estimated Implementation Costs</b> (mandatory by BSCCo)  £240 (one ELEXON man day) of effort to implement the necessary document changes.	
<b>Configurable Items Affected by Proposed Solution(s)</b> (mandatory by originator)  BSCP 128 ‘Production, Submission, Audit and Approval of Line Loss Factors’.
