## Issue 93 Workgroup 1 Summary

---

### Summary

#### 1 Meeting Objectives

The Chair welcomed attendees and presented the following meeting objectives to WG Members:

- Provide an overview of all the aspects associated with Issue 93.
- Confirm if there are any additional topics that should be covered as part of the Issue group.
- Determine a Prioritisation Process for progressing the Issue

#### 2 Workgroup Overview

2.1 Elexon confirmed whilst there are a number of aspects to the Issue that need to be covered in detail, if any 'Quick Win' Change Proposals can be identified these should be raised ASAP.

2.2 The WG discussed an approach of forming smaller breakout groups to discuss an individual aspect prior to presenting to wider WG.

2.3 The Elexon Metering team gave an overview of all aspect associated with Issue 93 and discussion was held over additional aspects which were identified as follows:

- Review use of PARh metering
- Gross Import and Export wording in different CoPs
- Use of more concise or clear language within CoPs
- Review of Metering Dispensations and if they are fit for purpose
- Security of Public v Private IP Comms
- DC Metering

#### 3 Prioritisation Process

Elexon demonstrated a Tracker to be used to help prioritise the different aspects discussed in the Issue Group, this will be shared with the group and members asked to provide the following information:

- Workgroup members:
  - What aspects are WG members interested in and feel they can contribute towards discussion
  - Perceived Industry Risk: The amount of time and resource spent on rectifying operational issues arising from this aspect
  - External Effort: The amount of effort it would take to implement changes for industry parties for a change proposal to rectify issues with this aspect
- Elexon:
  - Settlement Risk: The impact against relevant Risk(s) on the Risk Register
  - Internal Effort: The amount of effort it would take Elexon resource to prepare and manage a Change Proposal rectifying issues arising from this aspect.

#### 4 Next Steps

- Next WG meeting aimed to be held toward the end of March
- WG members to complete Priority Tracker within 10 Working Days of distribution

#### 5 Actions

- Elexon to confirm if MPANs Registered using CoPs 6, 7, 8 and 9 are being used or data errors.
  - WG members to provide data on any MPANs they have that are active
- Elexon to map Issue Form Aspects to Tracker Aspects
- WG members to confirm any additional Subject Matter Experts they feel can contribute to the Issue Group for specific aspects
- Elexon to look into the following areas and if they can be raised as 'Quick Win' Change Proposals:

- End Dating CoPs 6, 7, 8 and 9
- Removal of alarm notifications to a point which is normally manned and replace with Data Collector in CoPs
- Removal of PARh Metering from CoPs
- Tightening of Measurement Transformer and Metering Class Accuracy
