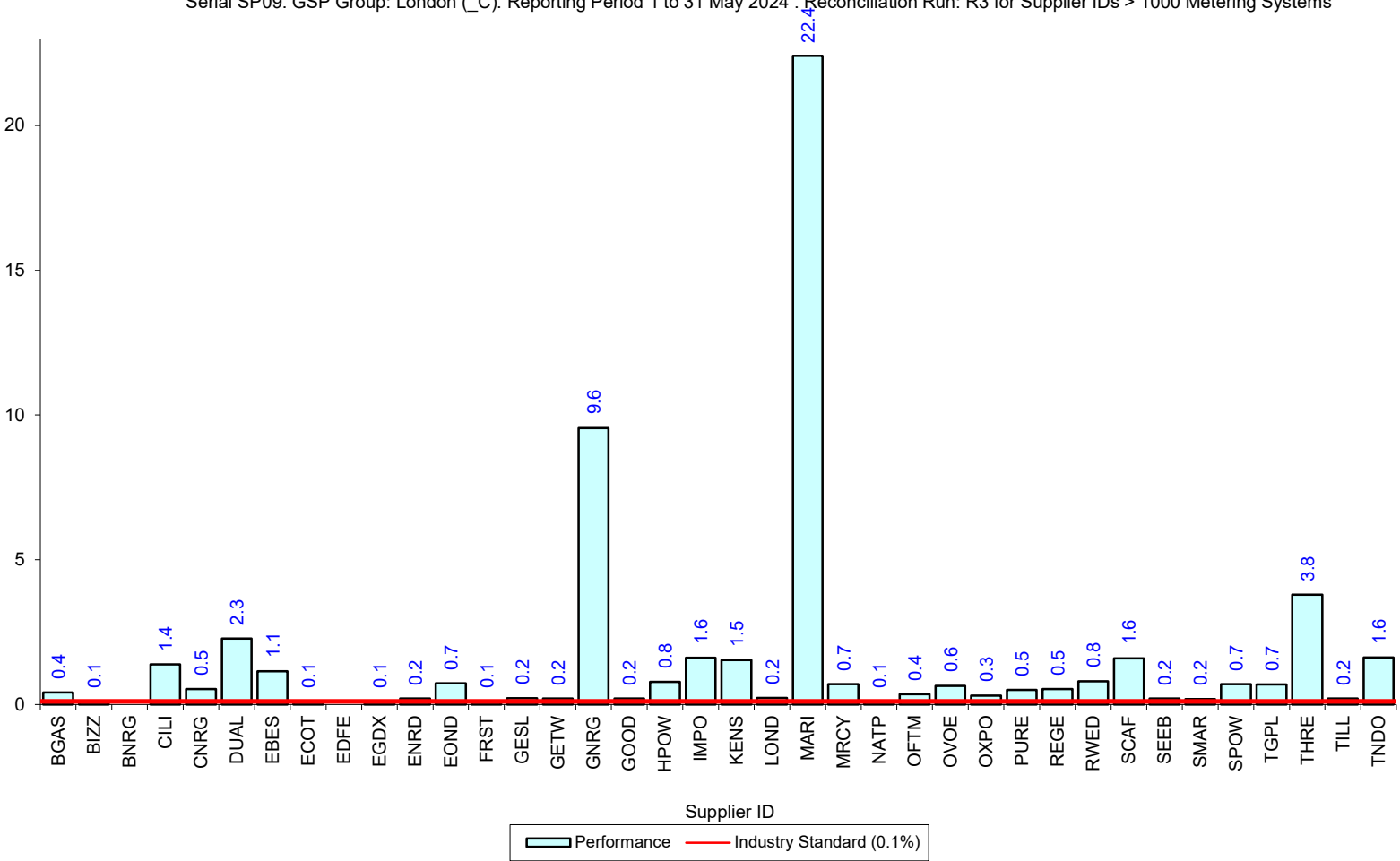

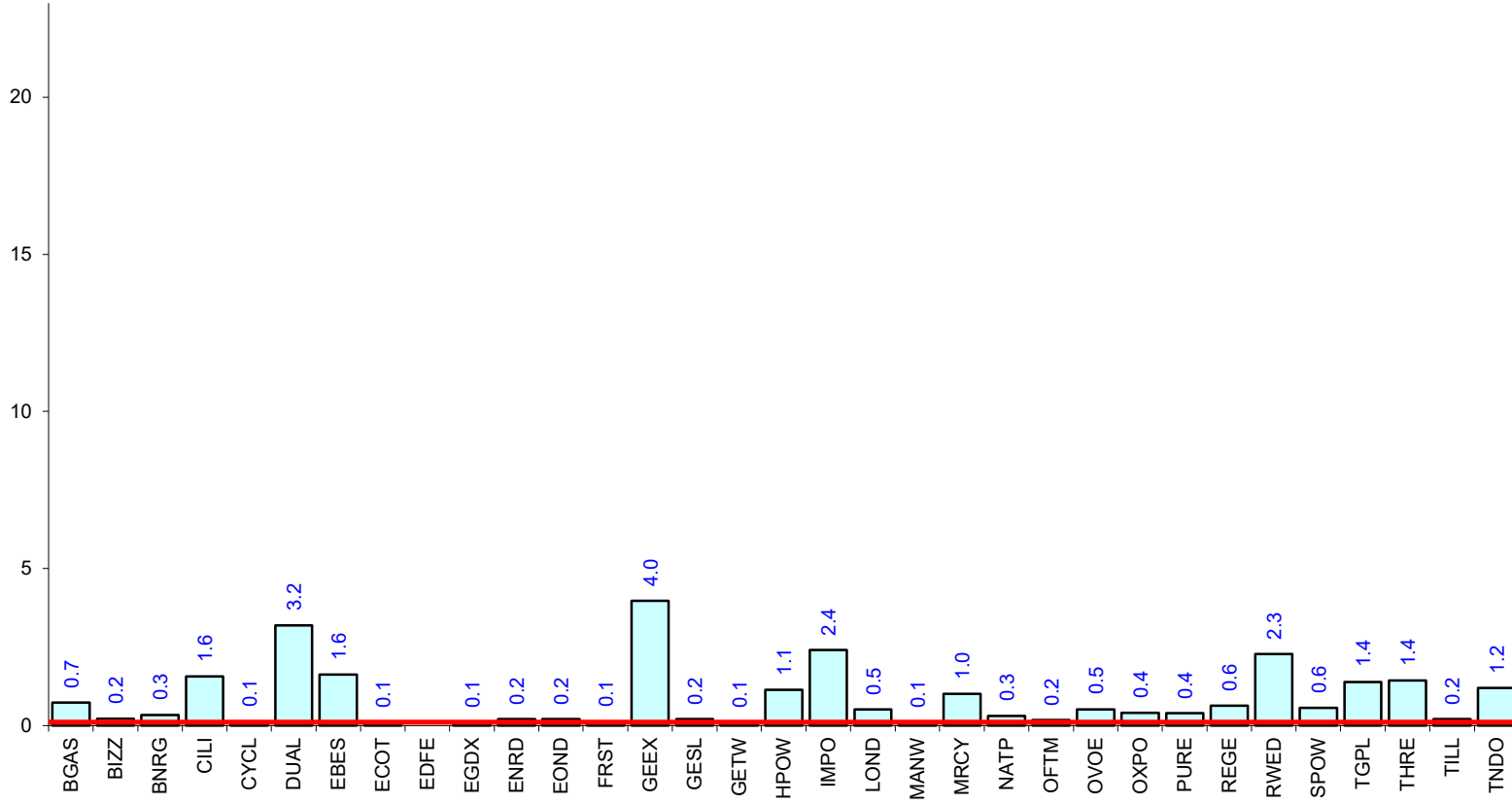

Percentage of Non Half-Hourly Metering Systems settled on a Default EAC

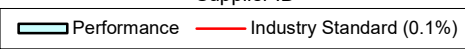

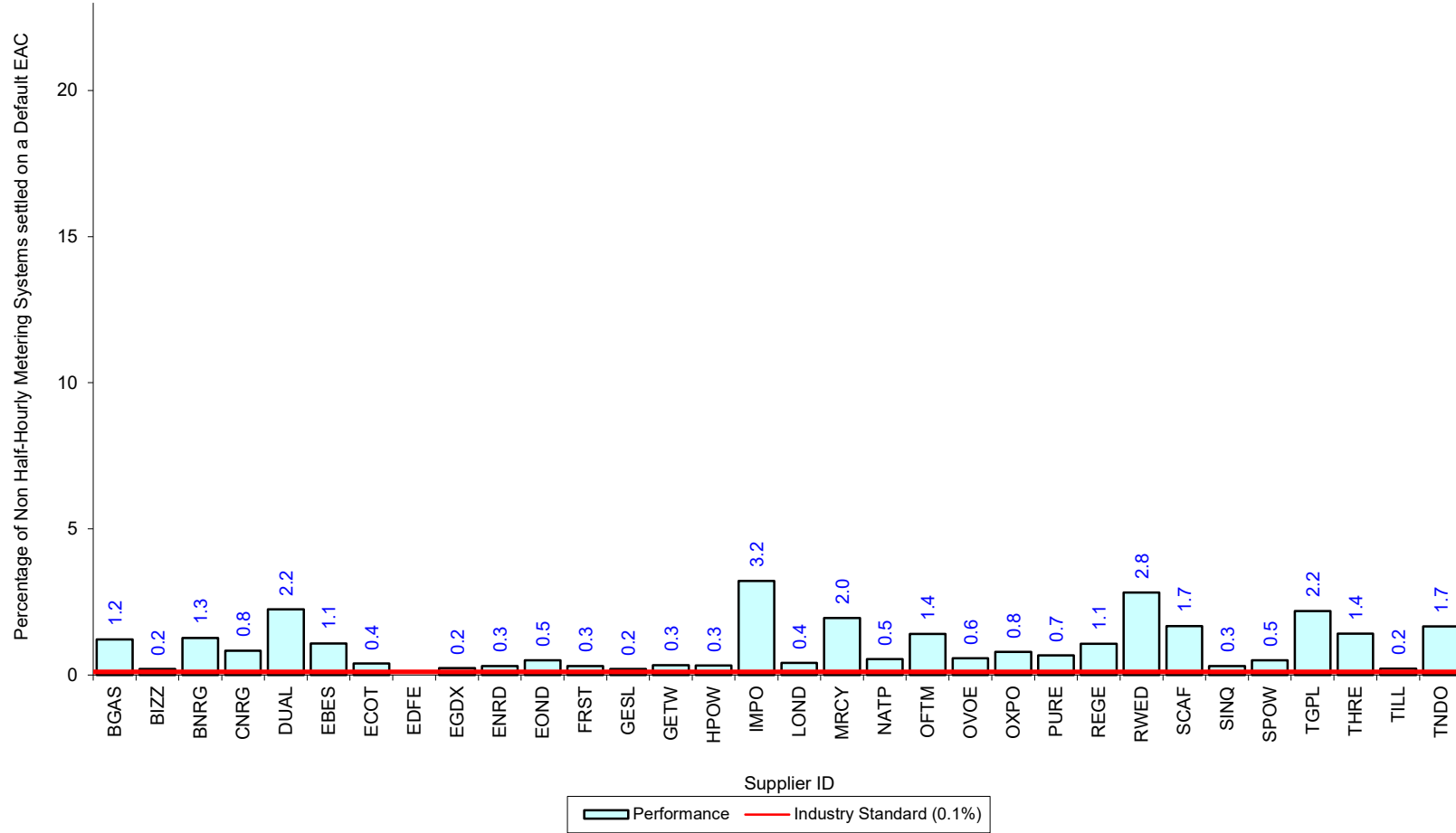
