

P259 – DRAFT PROPOSED LEGAL TEXT

SECTION K: CLASSIFICATION AND REGISTRATION OF METERING SYSTEMS AND BM UNITS (Version 32.0)

Insert new paragraph 5.8 to read as follows:

5.8 BM Units associated with Interconnectors for the purpose of sending Interconnector Equivalent Data to the BMRA

5.8.1 Subject to paragraph 5.8.2, for each Interconnector in respect of which the Transmission Company provides Interconnector Equivalent Data, the Transmission Company shall register a BM Unit for the purpose of sending Interconnector Equivalent Data to the BMRA and such BM Unit shall not be deemed to be a BM Unit for any other purpose under the Code.

5.8.2 Each BM Unit registered pursuant to paragraph 5.8.1 shall be registered in accordance with paragraphs 3.2.3 to 3.2.8 (inclusive) provided that paragraphs 3.2.3(c), 3.2.3(d), 3.2.3(e) and 3.2.6 shall not apply in respect thereof.

SECTION Q: BALANCING MECHANISM ACTIVITIES (Version 21.0)

Insert new paragraphs 6.1.24s to 6.1.27 (inclusive) to read as follows:

6.1.24 Subject to paragraph 6.1.26 and Section K5.8, the Transmission Company may send to the BMRA such data, in respect of an Interconnector, as the Transmission Company considers is equivalent to any of the data specified in paragraphs 6.1.9 to 6.1.11 (inclusive) to the extent that, in respect of each Interconnector, such data is available to the Transmission Company and it is practicable for the Transmission Company to commence sending it to the BMRA ("**Interconnector Equivalent Data**").

6.1.25 Where the Transmission Company has commenced sending Interconnector Equivalent Data in respect of an Interconnector pursuant to paragraph 6.1.24 and it has received an update of any such data, it shall send that Interconnector Equivalent Data to the BMRA in accordance with the timescales notified to BSCCo pursuant to paragraph 6.1.26(b).

6.1.26 The Transmission Company shall give reasonable advance notice to BSCCo where it intends to commence sending Interconnector Equivalent Data to the BMRA, or to change the derivation of such Interconnector Equivalent Data, and such notice shall include:

- (a) when the Transmission Company intends to commence sending, or change the derivation of, such Interconnector Equivalent Data;
- (b) the times by which the Transmission Company shall send that Interconnector Equivalent Data to the BMRA;
- (c) the BM Unit(s) (registered in accordance with Section K5.8) to which the Interconnector Equivalent Data relates; and
- (d) a description of the Interconnector Equivalent Data including details of the data specified in paragraphs 6.1.9 to 6.1.11 (inclusive) to which that Interconnector Equivalent Data corresponds.

6.1.27 BSCCo shall promptly notify Parties upon receipt of a notice from the Transmission Company pursuant to paragraph 6.1.26, and such notification shall include the information provided by the Transmission Company pursuant to paragraphs 6.1.26(a) to 6.1.26(d).

SECTION T: SETTLEMENT AND TRADING CHARGES (Version 18.0)

4. SETTLEMENT CALCULATIONS

4.1 Treatment of Interconnector BM Units

Insert new paragraph 4.1.3 to read as follows:

- 4.1.3 Following receipt of Applicable Balancing Services Volume Data from the Transmission Company, pursuant to Section Q6.4, in respect of an Interconnector BM Unit of an Interconnector Error Administrator for the Interconnector in question:
- (a) where QM_{ij} is positive or zero, the Applicable Balancing Services Volume Data shall be re-allocated to the Production Interconnector BM Unit of the Interconnector Error Administrator; and
- (b) where QM_{ij} is negative, the Applicable Balancing Services Volume Data shall be re-allocated to the Consumption Interconnector BM Unit of the Interconnector Error Administrator.

ANNEX X-1: GENERAL GLOSSARY

Amend Section X by amending the following definition in Annex X – 1 General Glossary:

"Applicable Balancing Services Volume Data": means the data in respect of a BM Unit and a Settlement Period representing volume of Active Energy associated with the provision of Applicable Balancing Services as sent by the Transmission Company to the SAA and BMRA pursuant to Section Q6.4 and (where applicable) re-allocated by the SAA pursuant to Section T4.1.3;

Amend Section X by inserting the following definition in alphabetical order into Annex X – 1 General Glossary:

**"Interconnector Equivalent
Data":**

has the meaning given to that term in Section Q6.1.24;
