Title <i>(mandatory by originator)</i> Removal of the definitions of Business Day and Working Day from Code Subsidiary Documents	
Description of Problem/Issue <i>(mandatory by originator)</i> A number of Balancing and Settlement Code Procedures (BSCPs) contain definitions of Business Day and Working Day. The Code also defines the terms Business Day and Working Day. The definitions of Business Day and Working Day within BSCPs differ between BSCPs and the Code, although the intended meaning in all documents is the same. The BSCPs state that where there is an inconsistency between the provisions of the BSCP and the Code, the provisions of the Code shall prevail. To prevent further inconsistencies occurring within the BSCPs should the definition of Business Day or Working Day be amended in the Code, the definitions of Business Day and Working Day should be removed from the BSCPs.	
Proposed Solution(s) <i>(mandatory by originator)</i> Remove the following definitions from the following BSCPs: BSCP501 Supplier Meter Registration Service – Remove the definition of Business Day and amend the definition of WD from 'The period from 09:00 to 18:00 (both inclusive) on any Business Day' to 'Working Day' BSCP534 PARMS Techniques – 1) Remove the definition of Working Days. 2) Move the text associated with this definition i.e. 'Throughout this procedure timescales are referred to in relation to the number of working Days (WD), unless specifically stated otherwise' to section 1.2 'Main users of the Procedure and their Responsibilities' BSCP601 – Appendix 3.8 Compliance Testing Specification 6-04 – Remove the definition of Business Day BSCP601 – Appendix 3.9 Compliance Testing Specification 5-06 – Remove the definition of Business Day BSCP601 – Appendix 3.10 Protocol Testing Specification – Remove the definition of Business Day Communications Requirement Document – Remove the definition of Working Day No other Code Subsidiary Documents have been identified as being impacted by this change as of 16 July 2003.
