

Change Proposal – BSCP40/02	CP No: 1242 <i>Version No: 1.0</i> <i>(mandatory by BSCCo)</i>
Title <i>(mandatory by originator)</i> Movement of the functional requirements within PSL 180 ‘CVA Meter Operation’ into BSCP06.	
Description of Problem/Issue <i>(mandatory by originator)</i> The Code Subsidiary Document (CSD) review has highlighted that there is a large amount of duplication between the requirements contained in Party Service Lines (PSLs) and the corresponding Balancing and Settlement Code Procedures (BSCPs). During a consultation as part of the CSD review, industry participants were asked whether the functional requirements of PSLs should be merged into the appropriate BSCP and a single PSL created containing non functional requirements relevant to all Party Agents. The majority of respondents to the consultation agreed with this recommendation. The Panel were asked to agree the recommendations of the CSD review and the CSD Architecture Principles Document at their meeting on 8 June 2006 (Panel 115/08). The Panel agreed that a single PSL should be created containing the non-functional requirements and the functional requirements in the existing PSLs should be merged into the relevant BSCPs. A single generic PSL, PSL100 ‘Generic Non Functional Requirements For Licensed Distribution System Operators and Party Agents’ has being created (under CP1182) containing participants non-functional requirements. Following on from CP1182, the functional requirements from the CVA Meter Operations PSL (PSL180) should be moved into BSCP06 ‘Notification and Sealing of Metering Equipment for Central Volume Allocation’. It is also proposed that BSCP06 should be renamed to BSCP06 ‘CVA Meter Operations for Metering Systems Registered in CMRS’ to accommodate these requirements.	
Proposed Solution <i>(mandatory by originator)</i> Since there is no specific BSCP for CVA Meter operations it is proposed to rename BSCP06 to BSCP06 ‘CVA Meter Operations for Metering Systems Registered in CMRS’ and place all of the functional requirements of PSL180 into the renamed BSCP06. Redlining to suggest where requirements currently in PSL180 should sit within BSCP06 are attached to this DCP (Attachment A). Guidance as to where requirements have been moved to (a mapping matrix) and where they have come from (a reverse mapping matrix) have also been provided as attachments (Attachments B and C). It is noted that this change will require additional more minor changes to other BSCP537 ‘Appendix 1 Self Assessment Document (SAD)’ to correct references to PSL180). This additional redlining is provided as Attachment D. A housekeeping modification will be needed to update/remove references to PSL180 within the BSC before PSL180 is entirely removed. For efficiency, it is anticipated that a single housekeeping	

modification will be used to update all of the PSL references when all of the functional requirements in the PSLs have been moved into BSCPs.

Justification for Change *(mandatory by originator)*

This change will move the functional requirements in PSL180 into BSCP06 and will mean that CVA Meter Operators will only have to look in BSCP06 to find the functional requirements relating to their role. This may be particularly useful to new entrants. It will also reduce the cost associated with preparing and maintaining numerous and duplicated PSLs.
