Title <i>(mandatory by originator)</i> SVA Data Catalogue: Correction of the "Host LDSO Name" data item description Description of Problem/Issue <i>(mandatory by originator)</i> The description of the data item "Host LDSO Name" in the SVA Data Catalogue Volume 2 refers to a PES Supply Licence relating to distribution activities in England and/or Wales at Code Effective Date. However with the introduction of P62 and the introduction of new distribution businesses into the market, this description is no longer appropriate. The note added against the Host LDSO Name data item for P62 is incorrect when it states that the 'Host LDSO' is equivalent to a 'Nominated LDSO' referred to in BSCP 515. There will only ever be one 'nominated LDSO' per GSP group, whereas there may be more LDSOs than this as new distribution businesses enter the market. The only use of Host LDSO Name data item in the SVA Data Catalogue Volume 1 is in the P0170 "HH Unmetered Supply Certificate" and P0207 "NHH Unmetered Supply Certificate" data flows. In the context of these data flows, an existing data item "LDSO ID" could replace its use thereby removing the need for a separate Host LDSO Name data item.	
Proposed Solution(s) <i>(mandatory by originator)</i> There are two possible solutions: 1) Remove "Host LDSO Name" from the SVA Data Catalogue Volume 2 and change the references to it in the P0170 "HH Unmetered Supply Certificate" and P0207 "NHH Unmetered Supply Certificate" data flows in SVA Data Catalogue Volume 1 to use "LDSO ID" instead. 2) Keep the Host LDSO Name data item but remove the text in its note section and amend its description as follows: Existing: "Licensed Distribution System Operator means a Party which is the holder of a Distribution Licence (acting in that capacity), who was the holder, or is a successor (in that capacity) to a company which was the holder, of a Public Electricity Supply Licence (PES Supply Licence) relating to distribution activities in England and/or Wales at the Code Effective Date." Proposed: "Licensed Distribution System Operator means a Party which is, or was, the holder of a Distribution Licence."
