Title (mandatory by originator) Clarification of methods for requesting reports under BSCP41

Description of Change (mandatory by originator)

Changes to BSCP41 to clarify the process for requesting reports and publication of an updated list of available reports.

This Change Proposal replaces NCR363

Proposed Solution(s) (mandatory by originator)

REPORT REQUESTS

Currently there are two methods for requesting reports under BSCP41; firstly to request reports defined as being available to "Any Party on Request" and secondly confidential reports ie reports classified as being available to the "Relevant Party". To clarify the process it is proposed that the procedure is broken down into 3 areas:

1) Amendments to a Parties or Party Agents Standard Reports

- a) This section will cover the standard set of reports automatically received by each Party and Party Agent and the process by which these reports are stopped or re-started.
- b) Before parties can receive data they are required to have successfully completed the Interface Tests detailed in the Communication Requirements Document. If a Party or Party Agent decides not to receive certain reports and avoid the associated Interface Tests they will initially complete BSCP41 and subsequently carry out test for the other flows ie in the case of MOAs there are 2 electronic and 2 manual flows. In this scenario a record needs to be kept of the flows which have not been tested to ensure that the appropriate Interface Tests can be undertaken if reports are subsequently requested. This section will detail the applicable process.

2) Reports Available to "Any Party on Request"

- a) Review current sections 1.1, 3.1 and 4.1 and clarify, as appropriate.
- b) Under the Code V 3.2.3 a Party is entitled to receive the report classified as "Any Party on Request" by notifying the BSCCo.

Where "the 'Recipient' column in any such Table includes 'Any Party (on request)', each Party shall be entitled to receive all such data if it notifies BSCCo to that effect in accordance with BSCP41."

Currently under BSCP41 BSCCo are not notified, report request flow to CRA should also be copied to BSCCo to meet Code obligation.

3) "Relevant Party" Reports Made Available to Another Party

- a) "Relevant Party" reports can only be made available to another party fulfilling the same Role and with the permission of the originating party. These reports can be made available on two different bases as a redirection or a copy; this section should clearly identify the associated processes.

AVAILABLE REPORTS

Currently a list of reports, as detailed in Section V of the Code, is available on the ELEXON Website. This list details which reports using the Logica IDD reference, however, Logica have a more detailed list which provides a complete breakdown, ie CRA-I014 has many sub reports depending on the individual roles. A new list should be produce, referenced in the BSCP and posted on the ELEXON Website.
