<b>Title</b> <i>(mandatory by originator)</i> Correction of qualification procedures in recognition of arrangements in place	
<b>Description of Change</b> <i>(mandatory by originator)</i> The qualification process as described in BSCP65, BSCP71 and BSCP531 assumes that the testing organisation is responsible for making a statement about the qualification status of the Party or Party Agent being tested. These BSCPs were written in advance of arranging the actual process and there is now a significant discrepancy between the process currently described and the process in use. In particular, ELEXON is responsible for making the statement about qualification status, based on tests done or waivers requested.  The proposed change requires that appropriate modifications be made to describe the process as it has been carried out under the NETA Programme and as it will be carried out by ELEXON.	
<b>Proposed Solution(s)</b> <i>(mandatory by originator)</i> This solution recognises that the new process description is longer than that which appeared in BSCP 65, BSCP71 and BSCP 531, and more forms are involved.  The proposal is: <ol style="list-style-type: none"> <li>1. To create a new BSCP to capture the qualification process. This will address: arranging for tests to be carried out; accepting waiver requests; and reporting of qualification status. A number of new forms will be introduced.</li> <li>2. To replace all references to qualification in BSCP65, BSCP71 and BSCP531 with a reference to the new BSCP.</li> <li>3. To change the Communication Requirements Document to recognise the level of evidence reporting required by the process.</li> </ol>	
<b>Justification for Change</b> <i>(mandatory by originator)</i> <ol style="list-style-type: none"> <li>1. To formally capture a process that is not currently adequately captured.</li> <li>2. To clarify the activities of Parties and Party Agents</li> <li>3. To clarify the boundaries of responsibility for ELEXON in assessing qualification status.</li> </ol>
