



**Redlined BSCP301 text for CP1486 'Removing example Advice Notes, Backing Sheets and Confirmation Notices from BSCP301'**

CP1486 proposes changes to Sections 4.2, 4.5.2, 4.6.1, 4.6.2, 4.6.3 and 4.7.

It also proposes to remove Sections 5.1.1, 5.1.3, 5.1.5 and 5.1.6.

We have redlined these changes against Version 16.0, which will go live as part of the June 2017 Release.
